#### 06/22 Opening and introduction of new CAB members and visitors

### 07/22 Tom Darell/CEO Nord Pool – introduction and thoughts on Nord Pool's future

Tom Darrel, Nord Pool's new CEO, introduced himself and gave some insight to Nord Pool's strategic direction. Nord Pool will continue to position itself in the heart of 3 core trends: Energy transition, Decentralization, and Digitalization, supporting customer's strategies towards net zero targets. Core areas for Nord Pool in addition to further development of current market to fit new needs are the inclusion of local energy markets, demand side management and local flexibility, green products and trading closer to delivery.

### 08/22 Flow Based in the Nordic Market: Presentation and discussion: Magnus Sunnefors

CAB was given a quick status about the external parallel runs for Flow Based Market capacity allocation in the Nordic market. Some core challenges were highlighted as well as progress with this extensive project. CAB members acknowledged the ongoing work and discussed different aspects and how to support and ensure that Flow Based testing is robust enough to capture the real impact to Day-ahead and Intraday markets. Various apprehensions and risks were put forth for discussion and its effects on the markets. Nord Pool assured the group to play a role in steering and putting forwards markets needs in the Flow based discussions at the relevant stakeholder gatherings.

### 09/22 Lack of liquidity in Nordic Financial market: Discussion warm up by some CAB members & Nord Pool

NAET and Volue presented their views on the current situation of financial power markets. Declining liquidity and absence of risk capital to balance the fundamental hedging is challenging for the complete market. Branch association, NAET, financial market operator and others are trying to engage stakeholders including TSOs to actively contribute to a market where hedging and forward trading can be conducted. Discussion with TSOs was identified as one of the important steps in order to address the

problem of many bidding areas and the importance of including the ability to hedge in their planning and market development.

### 10/22 Nord Pool Cyber Security Program by Neil Cash

As a part of the quickly changing situations politically and business needs, Nord Pool made clear that Secure operations is taken very seriously. Nord Pool's Cyber Security Manager apprised the group with various initiatives being undertaken to secure the system from malicious attacks.

#### 11/22 Nord Pool Market Surveillance Update

An update was given by Market Surveillance to the members, including recent projects. CAB members expressed their pleasure over the results of the threshold project. Some topics were suggested to Market Surveillance to investigate in further detail. Further, it was informed that Nord Pool won a 4-year tender to do market surveillance on behalf of the Finnish TSO, Fingrid.
