---

- Flexible Hourly Offer rephrased to Flexible Hourly Orders
  - Flexible Hourly Orders can now also be Buy Orders
  - Concerns point 2.5.2, 3.2 and 4.3
- Blocks Orders with Minimum Acceptance Ratio
  - The Minimum Acceptance Ratio of a Block Order allows the Block Order to be curtailed down to the set Minimum Acceptance Ratio
  - Additions written to point 3.3.1 and 4.3.2 a.
  - Acceptance ratio used also for linked orders. Point 4.3.3. c. added.

# Change to Trading Rules – General Terms:

---

- Amendment of General Terms Section 14.2 – point 14.2.2 – regarding information to member in the event that information is passed on to Transmission System Operators vs public authorities.

- Current 14.2.2:

*“NPS may pass on information to public authorities and Transmission System Operators if so required by Applicable Law or regulation. NPS will inform the Participant of such provision of information, to the extent it is permitted to do so under Applicable Law or regulation.”*

- New 14.2.2:

*“NPS may pass on information to public authorities. NPS may also pass on information to Transmission System Operators if so required by Applicable Law or regulation. NPS will inform the Participant of such provision of information to the Transmission System Operators to the extent it is permitted to do so under Applicable Law or regulation.”*
