### Service features

#### Service 2 Automated forwarding of data to ACER

Automatically report orders and trades placed in OTC markets and other organised marketplaces directly to ACER. Use Nord Pool's REMIT Portal to verify acceptance of data, extract receipts and prove REMIT compliance quickly and efficiently.

This service is available to all traders in the OTC wholesale electricity and gas markets reporting supply contracts. You do not have to be a Nord Pool member to use it.

Our API makes it possible to automatically upload and report OTC contracts and trades directly to the ACER system (ARIS). It provides transparent and accessible reports summarising all submitted data and ACER receipts – everything you need to be confident that your trades are compliant.

#### Service 3 Reporting bilateral contracts

For customers required to report bilateral electricity and natural gas supply contracts, Nord Pool can fulfil the role of a third party RRM. Nord Pool can also fulfil this role on behalf of third parties in the case of Third Party Reporting.

With opportunities to report on behalf of one or more counterparties and access to the OTC Portal to upload, store and manage bilateral contract information quickly and simply, Service 3 is versatile and practical. It even supplies you with an Excel template for executions, to help manage your reporting efficiently.

#### **REMIT API**

The REMIT API is included as part of our REMIT Reporting Services package. It enables customers to download data and ACER receipts and, for those using Service 2, to upload data and send it directly to ACER.

Using the API also enables you to integrate your internal systems with the REMIT Transaction Reporting Services facilitating easy, seamless compliance.
