- 4th February 2014: Baltic cable has implicit loss handling. Max ATC/NTC shows sending end value which is 615 MW in both directions.
- 6th February 2014: Max NTC from EE to FI changed from 1000 MW to 1016 MW.
- 30th May 2014: Max NTC on Latvia-Russia border changes from 0* to 291 MW on LV-RU and to 323 MW on RU-LV.
- 1st July 2014: Fenno-Skan 1 capacity was reduced permanently due to cable condition causing the total FI-SE3 capacity reduction from 1350 MW to 1200 MW to both directions.
- 3rd July 2014: restriction from Finland to Estonia removed due to commissioning of Kiisa ERPP 2. Max NTC value EE->LV changed from 925 MW to 1000 MW, NTC LV->EE changed from 850 MW to 879 MW.
- 26th November 2014: NO5-NO1 changed from 3500 MW to 3700 MW due to new system protection scheme.

- 27th November 2014: NO2-NO1 changed from 3200 MW to 3500 MW due to installation of new reactive components.
- 1st December 2014: Export from Finland to Russia is possible on maximum NTC 320 MW.
- 15th December 2014: Skagerak 4 was taken into commercial operation and increased the max NTC on the Skagerak connection between DK1 and NO2 from 1000 MW to 1632 MW in both directions.
